1. The Government of Nepal [GoN] **has allocated funds** towards the cost of National Information Technology Center and intends to apply part of the funds to cover eligible payments under the Contract for **Construction of Data Center at Kohalpur Municipality - 11, Loknagar, Banke**. Bidding is open to all eligible as per Section V of bidding document.
2. **National Information Technology Center** invites sealed bids or electronic bids from eligible bidders for the construction of **Data Center at Kohalpur Municipality - 11, Loknagar, Banke** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **289 million**
 - Minimum Work experience of similar size and nature: **300 Million**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

6. Pre-bid meeting shall be held at March 08, 2022 at 11:00 AM.
7. Electronic bids must be submitted to the office National Information Technology Center, Singhadurbar, Kathmandu through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Noon on March 20, 2022. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 PM on March 20, 2022 at the office of National Information Technology Center, Singhadurbar, Kathmandu. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format amounting to a minimum of NPR **9,700,000.00** which shall be valid for 30 days beyond the validity period of the bid (**i.e. August 17, 2022**)
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
